AIMS OF THE COURSE

The intensive course on Resilience Management in Cultural Heritage is meant to supply participants with notions and knowledge on protection from risks and on the resilience management of cultural heritage after damages or catastrophic events. The course will deal with the possible ways to face the increasing risks on which Cultural Heritage is subjected and on how to recover them to fruition and tourism considering the disasters that can be provoked in this field by climatic changes, natural events and conflicts. The implications that Resilience Management has got in the Management of emergencies and the different organizational approaches will be examined closely too in order to face prevention and recovery not only in technical/material terms but also in economic and social ones.
